Pursuant to Chapter 119. and section 5167.02 of the Revised Code, the Director of the Ohio Department of Medicaid (ODM) gives notice of ODM's intent to consider the amendment of the rules identified below and of a public hearing thereon.

Rule 5160-26-02.1, "Managed health care programs: termination of enrollment," sets forth reasons why an individual enrolled in a managed care organization (MCO) or the single pharmacy benefit manager (SPBM) may be terminated and the process for termination. The rule is being proposed for amendment to update policy related to administration of the Medicaid managed care program. Changes to the rule include: removing language in paragraph (E)(3)(f)(1) to align with federal requirements and reduce administrative burden.

Rule 5160-26-08.4, "Managed health care programs: managed care plan appeal and grievance system," sets forth the appeal and grievance rights and responsibilities for MCOs, the SPBM, and the members enrolled with those entities. This rule is applicable to MCOs, the SPBM, and the OhioRISE plan. The rule is being proposed for amendment to update policy related to administration of the Medicaid managed care program. Changes to the rule include: revisions to ODM form dates to reflect the most recent form revision dates.

Rule 5160-26-12, "Managed health care programs: member co-payments," sets forth requirements for MCOs and the SPBM when they elect to implement a co-payment program. This rule is applicable to MCOs and the SPBM. The rule is being proposed for amendment to update policy related to administration of the Medicaid managed care program. Changes to the rules include: revising language to align with ODM policy initiatives to extend the post-partum coverage period to twelve months.

ODM will hold the public hearing for this rule package via teleconference and in-person. All inperson attendees are required to follow Lazarus building COVID-19 safety protocols when inside the ODM office. ODM will not require masks for individuals entering the building. However, visitors are welcome to wear masks if that is their preference. Masks are encouraged if visitors are not up to date with vaccine and boosters, have an immune disorder, or chronic medical condition(s). ODM encourages social distancing in all areas of the office. The date and time for the public hearing are listed at the top of this Notice as well as the phone number, PIN (access code), and link for teleconference attendance, and location for in-person attendance.

All interested parties are invited to participate in the public hearing. Both oral and written

want to give oral testimony are asked to send a message by e-mail to <u>Rules@medicaid.ohio.gov</u> no later than one hour before the hearing to be added to the witness list. Those attending in person can be added to the witness list at the hearing. There will be a final call at the end of the hearing for persons who wish to offer oral testimony but are not yet on the witness list.

Written comments submitted in-person, by e-mail, postal mail, or fax that are received or postmarked no later than the day of the hearing will be accepted as testimony and will become part of the hearing record. All testimony will become public record; therefore, ODM asks that protected health information (PHI) be excluded unless the information belongs to the person submitting the testimony orto a person for which the submitter is a legal guardian. Written testimony sent by e-mail is highly recommended. All persons who submit testimony by e-mail will be sent a confirmation of receipt.
