In accordance with Chapter 119 of the Revised Code, the Ohio Department of Agriculture will conduct a public hearing for the purpose of soliciting comments regarding the adoption, amendment and recission of rules.

The public hearing will **be from 10:00 am to 10:30 am** or until all parties in attendance have had the opportunity to be heard.

The following rules are proposed for amendment:

Food Safety- Ch 1 Food Processing and Manufacturing Practices, Standards of Identity, and Labeling Requirements

OAC 901:3-1-11, 901:3-1-12, 901:3-1-14, 901:3-1-15: This rule package consists of two amended rules and two new rules proposed by the Ohio Department of Agriculture (Department) as part of the statutory five-year review.

Food Safety- Ch 3 Thermally Processed Low-Acid Foods Packaged in Hermetically Sealed Containers

OAC 901:3-3-01 through 901:3-3-18: This rule package consists of eighteen rescinded rules proposed by the Ohio Department of Agriculture (Department). Ohio Administrative Code Chapter 901:3-3 establishes requirements for thermally processing low acid foods in hermetically sealed containers, including standards for equipment, handling, processing, and packaging. The rules are proposed for rescission, as the inspections required by the rules are currently being performed by the U.S. Food and Drug Administration (FDA).

Food Safety- Ch 4 Retail Food Safety Establishments- Licensing

OAC 901:3-4-01 through 901:3-4-18: This rule package consists of eighteen amended rules proposed by the Ohio Department of Agriculture (Department) as a part of the statutory five-year review process. Ohio Administrative Code (OAC) Chapter 901:3-4 establishes licensing requirements for retail food establishments.

Food Safety- Ch 18 Processing and Production Records

OAC 901:3-18-01 through 901:3-18-04 This rule package consists of four new rules proposed by the Ohio Department of Agriculture (Department) as a part of the statutory five-year review process. The rules in this package are proposed new rules that adopt, modify, amend, and delete federal statutes concerning mitigation strategies to protect food from intentional adulteration.

Food Safety- Ch 24 Sanitary Transportation of Human and Animal Food

OAC 901:3-24-01 through 901:3-24-04: This rule package consists of four new rules proposed by the Ohio Department of Agriculture (Department) which incorporates by reference the requirements found in 21 C.F.R. Chapter 1, Subchapter A, Part 1, Subpart O (2023) regarding the sanitary transport of human and animal food.
