The following rules are proposed for amendment:

Markets Ch 4 Ohio Proud

OAC 901:4-6-03, 04 05: This rule package consists of three amended rules as part of the statutory five-year review process.

Food Safety Ch 17 Federal Food Safety Regulations

OAC 901:3-17-01: This rule package consists of one amended rule as a part of the statutory five-year review process.

Food Safety Ch 44 Federal Food Safety Regulations

OAC 901:3-44-01: This rule package consists of one amended rule as a part of the statutory five-year review process.

Food Safety Ch 46 Federal Food Safety Regulations

OAC 901:3-46-01, 02, 03, 04, 05, 07: This rule package consists of six amended rules as a part of the statutory five-year review process.

Plant Health Ch 7 Commercial Feed

OAC 901:5-7-01 through 10, 12 through 25: This rule package consists of two new rules, five amended rules and 20 rules that will be rescinded. This rule review is part of the statutory five-year review process and will be incorporating by reference the Association of American feed Control Officials (AAFCO) Model Bill.
