In accordance with Chapter 119 of the Revised Code, the Ohio Department of Agriculture will conduct a public hearing for the purpose of soliciting comments regarding the adoption, amendment and recission of rules.

The public hearing will **be from 10:00 am to 10:30 am** or until all parties in attendance have had the opportunity to be heard.

The following rules are proposed for amendment:

Plant Health Ch 58 Notice of Quarantine Box Tree Moth

OAC 901:5-58-01 through 05: This rule package consists of five new rules.

Plant Health Ch 41 Strawberry Rule

OAC 901:5-41-01: This rule package consists of one rule which ODA is proposing to rescind as a part of the statutory five-year review process.

Fair Concession Licenses

OAC 901:9-2-02 through 901:9-2-20: This rule package consists of eighteen amended rules as a part of the statutory five-year review process.

Persons affected by the proposed rules may appear and be heard in person, by an attorney, or both, or may present their position, arguments, or contentions, orally or in writing. Persons may offer and examine witnesses and present evidence tending to show that the proposed rules will be unreasonable or unlawful if enacted.
