In accordance with Chapter 119 of the Revised Code, the Ohio Department of Agriculture will conduct a public hearing for the purpose of soliciting comments regarding the adoption, amendment and rescission of rules.

The public hearing will **be from 10:00 am to 10:30 am** or until all parties in attendance have had the opportunity to be heard.

**The following rules are proposed for amendment:**

### **Animal Health Ch 1 Exhibition of Animals**

**OAC 901:1-18-01 through 11:** This rule package consists of eleven amended rules as part of the statutory five-year review process.

### **Livestock Exhibition Ch 19**

**OAC 901:19-01 through 07; 09 through 13, 19, 21, 31, 32, 34, 35, 38, 39 and 40:** This rule package consists of seventeen amended rules and four rescinded rules as part of the statutory five-year review process.

Persons affected by the proposed rules may appear and be heard in person, by an attorney, or both, or may present their position, arguments, or contentions, orally or in writing. Persons may offer and examine witnesses and present evidence tending to show that the proposed rules will be unreasonable or unlawful if enacted.
