## **Consolidated Summary of Comments Received**

The Ohio Renal Association submitted comments on Rules 4723-23-03 and 4723-23-10, OAC, on September 18, 2018 (Hearing Exhibit 5). The comments were in support of the rule changes. Karin Grant appeared as an interested party at the hearing on September 21, 2018, to testify regarding Rule 4723-9-10, OAC. Ms. Grant stated the proposed rule changes related to chronic pain management with opioids were clearly written and appreciated that step-by-step approach. She stated the language is complex and was present today to ask two questions about how to implement the rules in the hospital setting. She was encouraged to contact Board practice staff with questions, and to look for FAQs and other written articles regarding the rule language. She asked if the language was similar to the chronic pain rule language proposed by the Medical Board. She was advised that while testimony could not be given at the rules hearing on this, the drafting intent was that the language mirror that for physicians in the Medical Board Rule. She stated she had no objections to the rule proposal.
