Hi, Chuck.



Please accept my apologizes for failing to respond to your questions below. Our staff met to discuss implementation of the proposed rule, which included your concerns, and I missed circling back around to you. Thank you for providing us with implementation questions from the Program Director point of view. The timeline being added in our rule is not a change, but rather a codification of the requirements that have been in place for many years under the National Registry policies. The change will be in who will be monitoring the timelines for Ohio certification. I will address each of your questions/concerns as presented:

- 1) Program coordinators do not have access to the dates when tests occur (unless the test happens at their own site)
 - a. Without a change in the data from NREMT, I do not know how we can be expected to manage this.

The current rules require the programs to notify the students of the process for testing and certification. The information regarding the results of the written and practical exams only remaining valid for one year, based on past National Registry requirements, should be part of the information currently provided by the schools. The information will need updated since issuance of a National Registry certificate will no longer automatically mean eligibility for Ohio certification. I anticipate a template will be drafted that can be used by the schools with the ability to add school-specific notification requirements. The automated messages that are currently being sent out by our system when the school verifies course completion and eligibility for Ohio certification will also be updated to include reminders to the students of the time constraints on completing components of the examination and for making application for certification.

At the Advanced and Paramedic levels, (unless there has been a recent change) I believe the program director can see the date when a student passed the practical examination even if the student had to retest at another location. If the student is beyond the one-year time limit, she/he would need to complete a new practical examination before the school approves the student to begin the Ohio application process. Currently, a student can register for the practical exam at any school. If they are not on the National Registry roster of students, the students can still test. We will be meeting with the National Registry to discuss a process for sending those skill sheets to our office for final review. Our office could then notify the school of the new practical exam date. We will also be making changes to our course tracking site to better track the exam dates.

At the EMR and EMT level, the Program Director currently lists the completion date of the practical exam in our course tracking system. If the exam is more than one year old when the written exam is passed, the student can return to the school of training to retake the practical. If the school wants to accept a practical exam conducted by another accredited school, verification of the examination would need to be provided to the school that provided the EMR/EMT course to the student. We are looking at possible changes in the course tracking system to allow for the input of the new practical exam date.

- 2) If a student has to retake the cognitive exam AFTER the NREMT has already given that person a certification card, I assume the student will need to use the assessment test.
 - a. There will need to be a process in place so we can direct the student correctly.

The assessment exam is currently being used for various purposes in Ohio (EMS instructor knowledge exam, examination in lieu of continuing education, students under the age of 18, and reinstatement examinations). These requests are currently reviewed by DEMS staff to determine eligibility for the requested exams, and the approval for testing is made by our office. We will be working with the National Registry to discuss the possibility of adding a reason for testing to specifically address these students and we can certainly create an outline of the process to provide to students. We recognize there will always be reasons why a student may not be able to complete both the written and practical examination and make application for certification within 1 year of course completion. However, we believe the number can be kept to a minimum with the testing and certification guidance provided to students at the end of the course, and repeated notifications through the DEMS email notifications.

- 3) Regarding the practical exam, it needs to be clear when the date of the exam occurs ...
 - a. Consider a paramedic student who takes and passes 4 of the 6 stations on 01/01/18.
 - b. She then retests and passes the other 2 stations on 03/01/18.
 - i. Which date is used?

The intent is to continue to follow the policy that has been used by the National Registry for many years. In the scenario you provided, the recorded exam date would be 3/1/2018 as that is the date when the student successfully completed a full practical examination.

I hope I have addressed your questions/concerns. We will continue to work with our EMS partners to work through any concerns regarding the examination and certification process. Please contact me if you have further concerns or questions.



Amended rule 4765-8-05 (*Examinations*.) was filed with the Joint Committee on Agency Rule Review (JCARR) on September 14, 2018.

Chapter 8 (Certificate to Teach or Practice; Continuing Education)

4765-8-05 Amend Examinations.

The rule is proposed for amendment to state in rule existing policy that makes successfully completed written and practical portions of examinations for those seeking to be certified or seeking renewal of a certificate to practice as an EMR, EMT, AEMT, or paramedic valid for one year from the date of completion.
