The purpose of this rulemaking is to propose new rules, rule amendments, and rule rescissions to match the Ohio Hazardous Waste Management rules to recent amendments to their federal counterpart rules in 40 CFR Parts 260, 261, 262, 263, 264, 265, 266, 268, 270, 273, and 279 under the Federal Resource Conservation and Recovery Act (RCRA), as those federal rules were promulgated in the Federal Registers (FR) shown below. Ohio statute requires Ohio's rules to be equivalent to their federal counterpart regulations. This rulemaking also accomplishes the required 5-year review of a number of the Ohio rules in this rulemaking.

These rules address Hazardous Waste Management rules. The FRs listed below created, rescinded, or amended the federal RCRA counterpart regulations that correspond to the Ohio rules listed in this notice.

Ohio EPA held a public hearing on Monday, August 17, 2020 regarding the proposed rules in what is commonly referred to as the Hazardous Waste Management "Set Gen" rules package, which contained 133 amended, rescinded, and new rules. This document summarizes the comments received at the public hearing, and during the public comment period which ended at the close of business on Monday, August 17, 2020.

Ohio EPA reviewed and considered all comments received during the public comment period. By law, Ohio EPA has authority to consider specific issues related to protection of the environment and public health.

In an effort to help you review this document, the questions are grouped by topic and organized in a consistent format. The name of the commenter follows the comment in parentheses.

No comments were provided during the public hearing. There was one letter of comment received during the public comment period on these rules. It was from Ohio Environmental Services Industries (OESI), which is a trade association comprised of commercial hazardous waste management facilities and affiliated businesses within Ohio, an association of chemical recycling, treatment and disposal facilities.
