Many of the commenters asked for additional reimbursement for home health services and private duty nursing. Comments also proposed changes to the reimbursement methodology for these services.

In addition, some commenters suggested elimination of the RN Assessment and RN Consultation services. Commenters also suggested that the definition of skilled nursing services in home health be expanded to include the tasks performed during these services.

Some commenters supported changes allowing advance practice registered nurses to order home health and private duty nursing services. Commenters also supported the rule modifications allowing the use of telehealth as clinically appropriate when providing these services.
