Opiant requested that the Department make general changes to rules, including rules not already in this rule package. The request would be to change the use of Narcan/naloxone to placeholder overdose reveral medicaition.

OATOD made a number of requested changes to the rules. The new language regarding "stable patient" in 5122-40-01 was requested to be removed. In 5122-40-08, it was requested that paragraph (C) be rewritten to be clearer. In 5122-40-00, paragraph (C) was requested to be changed to remove the paragraph relating to stable patients.

OAAPN is requesting that advanced practice nurses be added to allowed practioners in several locations in these rules, along with the addition of certified nurse midwife, clinical nurse specialist, and certified nurse practitioner.

The Department is not incorporating changes requested by Opiant as the request is based on possible future changes in statuory authority.

The Department is incorporating the OATOD requests, removing requested language and rewriting 5122-40-08(C).

In response to the request from OAAPN, the Department is not making changes 1 as the request is not in line with federal regulations, with the exception of one item in 5122-40-06. In that rule the Department will be adding "authorized prescriber" as requested, the Department does have the authority to act in those areas.
