## **Consolidated Summary of Comments Received**

We received 43 comments: 14 comments pertain to rules 164-1-01 to 164-1-40 and 29 comments pertain to rules 164-2-03 to 164-2-26. Comments were reviewed to determine if a change is needed to provide clarification, to revise the intent to accomplish program goals, or to resolve identified issues.

For rules 164-1-01 to 164-1-40, 11 comments are inquiries regarding items that are clearly stated, therefore, no changes are needed (164-1-01, 164-1-33, 164-1-34, 164-1-35, 164-1-36, 164-1-38, 164-1-39); and the remaining 4 comments pertain to 3 rules that require changes (164-1-15, 164-1-34, 164-1-40).
