The purpose of this memo is to provide you with an update to the Bureau of Motor Vehicles' (BMV) response to your review and recommendations for Chapter 4501:1-3 (Motor Vehicle Dealers and Salespersons) completed on October 30, 2012.

Subsequent to the CSI review of the Chapter 4501:1-3 rule package, rules 4501:1-3-07 (Law enforcement report required with application) and 4501:1-3-09 (Registrar shall deny license) were submitted without change as part of the Chapter 4501:1-3 rules package filed with JCARR on January 23, 2013. It was later learned that the materials incorporated by reference were to be published in the rules; therefore the two above mentioned rules were subsequently withdrawn. The agency has amended the rules to include all materials incorporated by reference. The amendments did not materially change the rule or change the adverse impact to the regulated business community as described in the revised BIA provided to CSI on April 3, 2013. The agency intends to file the rules with JCARR on Monday, June 17, 2013, as a new filing.

Pursuant to R.C. 119.03, the Motor Vehicle Dealer Licensing Board (Board) plans to conduct a public hearing for 4501:1-3-07 and 4501:1-3-09 on Thursday, July 25, 2013, at 10:00 a.m. at the Ohio Department of Public Safety, Hearing Room 109, 1970 West Broad Street, Columbus Ohio, 43223. The Board anticipates final-filing the rule Thursday, August 22, 2013, with an effective date of September 2, 2013.

Thank you for your timely review of the business impact analysis for Chapter 4501:1-3 (Motor Vehicle Dealers and Salespersons) of the Administrative Code. The Ohio Department of Public Safety, Bureau of Motor Vehicles (BMV), has received and read your review, recommendations, and conclusions.
