Thank you for your review of the business impact analysis for Chapter 4501-7 of the Administrative Code (driver training schools). The Ohio Department of Public Safety, Office of Criminal Justice Services, Driver Training Program has received and read your review and recommendations, and conclusions.

On September 16, 2014, The Office of Criminal Justice Service, Driver Training Program intends to formally file Chapter 4501-7 of the Administrative Code and all the required materials with the Joint Committee on Agency Rule Review and the Legislative Service Commission. The Office of Criminal Justice Service, Driver Training Program plans to conduct a public hearing for the rules proposed for amendment pursuant to R.C. 119.03 on October 24, 2014 at 10am at the Ohio Department of Transportation, Room GB, 1980 West Broad Street, Columbus, Ohio 43223. The Office of Criminal Justice Service, Driver Training Program anticipates final-filing the rule with an effective date of December 1, 2014. This memo is to provide you with an update to the July 23, 2014 filing of Ohio Administrative Code (O.A.C.) Chapter 4501-7 pertaining to Commercial Driver Training Schools.

The Ohio Department of Public Safety, Office of Criminal Justice Services, Driver Training Program (the "department"), was contacted by JCARR who identified an error in O.A.C. rule 4501-7-24 pertaining to biennial CDL driver training school license renewals.

In response, the Office of Criminal Justice Services, Driver Training Program, withdrew the rule from JCARR, reviewed the rule and the accompanying statute, and found that JCARR was correct. Section 4508.05 of the Revised Code provides for annual renewal of these licenses.

Pursuant to the review, O.A.C. rule 4501-7-24 was revised to comply with statute, and as the rule is subject to CSI, the rule was resubmitted to stakeholders for their feedback. Stakeholders were specifically asked to address any additional adverse impact that the revision may pose, and no additional impact was identified.

The department intends to originally file this rule with JCARR tomorrow pursuant to its review. If you have additional questions, comments or concerns please feel free to contact my office.
