Thank you for your review of the business impact analysis for Chapter 4766-2 (*Ambulances*) of the Administrative Code. The Ohio Department of Public Safety (ODPS), Division of Emergency Medical Services (EMS), has received and read your reviews, recommendations, and conclusions.

By mid-November 2016, the Division of EMS intends to formally file Chapter 4766-2 of the Administrative Code and all required materials with the Joint Committee on Agency Rule Review and the Ohio Legislative Service Commission. The Ohio Department of Public Safety, Division of EMS wants to update the Common Sense Initiative Office regarding Ohio Administrative Code Chapter 4766-2 (*Ambulances*). The rule package was submitted to CSI on June 29, 2016. CSI's review memorandum for O.A.C. Chapter 4766-2 was received by the Division of EMS on August 31, 2016, and the Division's reply to CSI was also dated August 31, 2016.

To keep language consistent in O.A.C. medical transportation chapters 4766-2, 4766-3, and 4766-4, revisions to four rules in O.A.C. Chapter 4766-2 will be made before the chapter is original filed with the Joint Commission on Agency Rule Review. The changes are a result of comments received from stakeholders commenting on the additional chapters that will be filed with CSI in the future. The revisions are:
