The Common Sense Initiative is established in R.C. 107.61 to eliminate excessive and duplicative rules and regulations that stand in the way of job creation. Under the Common Sense Initiative, agencies must balance the critical objectives of regulations that have an adverse impact on business with the costs of compliance by the regulated parties. Agencies should promote transparency, responsiveness, predictability, and flexibility while developing regulations that are fair and easy to follow. Regulatory Intent

2. Please briefly describe the draft regulation in plain language.

OAC 5101:2-5-02 entitled Application for an agency to perform specific functions; amended applications provides guidance to agencies on the process of applying for certification. Paragraph (A) was amended to remove the date from form JFS 01290..

OAC 5101:2-5-03 entitled Certification of an agency an agency to perform specific functions provides guidance to agencies on what functions for which an agency may receive a certificate. A new paragraph (E) was added to specify the length of an agency certificate and some reasons for a possible extension. Paragraph (G) was amended to remove specific rule chapter numbers.

OAC 5101:2-5-04 entitled Recertification of an agency an agency to perform specific functions provides guidance to agencies regarding the procedure for recertifying. Paragraph (E) was amended to reference the new extension process as prescribed in rule 5101:2-5-03 of the Administrative Code.

OAC 5101:2-5-13 entitled Required agency policies, plans and procedures provides guidance to agencies on what specific policies and plans are required. A new paragraph (A)(17) was added to ensure an agency operating a residential facility has a policy that complies with the qualified

residential treatment program (QRTP) as described in rule 5101:2-9-42 of the Administrative Code.

Rules 5101:2-5-02, 5101:2-5-03, 5101:2-5-04, and 5101:2-5-13 do not implement a federal requirement.

All of the rules are a result of the general rule writing authority regarding the safety of children in care as directed in section 5103.03 paragraph (A) of the Revised Code.

For rule 5101:2-5-02, the purpose of the regulation is to provide guidance regarding the agency application to perform specific functions and amended applications.

For rule 5101:2-5-03, the purpose of the regulation is to provide guidance to agencies on specific functions that an agency may be certified to perform.

For rule 5101:2-5-04, the purpose of the regulation is to provide guidance regarding the procedure for recertifying an agency certificate.

For rule 5101:2-5-13, the purpose of the regulation is to provide guidance regarding the required agency policies for the functions for which the agency is certified.

7. How will the Agency measure the success of this regulation in terms of outputs and/or outcomes?

Rules 5101:2-5-02, 5101:2-5-03, 5101:2-5-04, and 5101:2-5-13 will be measured against the criteria specific to the rule content. Licensing specialists will monitor compliance ensuring the health and safety of children in care and preventing those who are ineligible/prohibited to provide care.

Development of the Regulation

9. Please list the stakeholders included by the Agency in the development or initial review of the draft regulation.

If applicable, please include the date and medium by which the stakeholders were initially contacted.

ODJFS has met with Ohio Children's Alliance (OCA), the Public Children Services Association of Ohio (PCSAO), and other representatives from county and private agencies through regional meetings and on several other occasions during the past few months to discuss the draft rules. Discussions were held by video-conference, phone, and through email communication. The groups discussed potential changes and provided feedback.

10. What input was provided by the stakeholders, and how did that input affect the draft regulation being proposed by the Agency?

ODJFS worked with Ohio Children's Alliance (OCA), the Public Children Services Association of Ohio (PCSAO) and discussed the rules in multiple meetings. They all were in favor of the certificate extension as mentioned in rules 5101:2-5-03 and 5101:2-5-04. The rules went through the clearance process from May 21, 2021 through June 4, 2021. No comments were received.

11. What scientific data was used to develop the rule or the measurable outcomes of the rule? How does this data support the regulation being proposed?

Not applicable.

12. What alternative regulations (or specific provisions within the regulation) did the Agency consider, and why did it determine that these alternatives were not appropriate? If none, why didn't the Agency consider regulatory alternatives?

There were no other alternatives considered for rules 5101:2-5-02, 5101:2-5-03, 5101:2-5-04, and 5101:2-5-13 because the rules are driven by statute.

13. Did the Agency specifically consider a performance-based regulation? Please explain. Performance-based regulations define the required outcome, but don't dictate the process the regulated stakeholders must use to achieve compliance.

Performance-based regulations were not considered in the context of safety standards for children in custody, which are largely driven by state and federal statute.

14. What measures did the Agency take to ensure that this regulation does not duplicate an existing Ohio regulation?

There is no duplication as the rules are specific to foster care agencies and no other rules address these specific issues. These rules were reviewed by the legal staff at ODJFS prior to the clearance process to ensure they do not duplicate any existing Ohio regulations.

15. Please describe the Agency's plan for implementation of the regulation, including any measures to ensure that the regulation is applied consistently and predictably for the regulated community.

ODJFS licensing specialists review the agencies to ensure the regulations are applied consistently and they offer technical assistance to providers.

Adverse Impact to Business

The rules included in this BIA contain requirements for foster care agencies that include eightyeight public and over one hundred private agencies. Requirements must be met in order to obtain and/or maintain certification.

The adverse impact for each of the requirements would vary based upon the size and staffing of each agency and would include the actual cost of completing each requirement, in addition to the time needed for staff to complete the requirement and report or enter the needed information for rule compliance in meeting the requirement. More specifically, the adverse impact includes:

5101:2-5-02

- a. Agencies must complete an application for approval to operate functions certified by ODJFS. The cost of completing this application process as required by this rule can involve time spent completing the form as well as collecting all of the required documentation.
- b. A social worker, administrators or a team of workers would be implementing the requirements of this rule. The current average wage for a social worker is \$22 per hour, according to Zip Recruiter. The anticipated time involved could be between 10-12 hours per person.
- c. Therefore, the anticipated cost of compliance for an impacted entity to comply with the rule is \$220 to \$264 per person, depending on administrative and staffing variables. There is no additional cost as a result of the rule amendment.

5101:2-5-03

- a. Agencies can review the certification categories approved by ODJFS.
- b. The is no cost involved with this rule as it is an informative rule related to the approved functions of agencies.
- c. There is no additional cost as a result of the rule amendment.

5101:2-5-04

- a. Agencies must complete a re-application for approval to continue to operate functions certified by ODJFS. The cost of completing this re-application process as required by this rule can involve time spent completing the form as well as collecting all of the required documentation.
- b. A social worker, administrators or a team of workers would be implementing the requirements of this rule. The current average wage for a social worker is \$22 per hour, according to Zip Recruiter. The anticipated time involved could be between 10-12 hours per person.
- c. Therefore, the anticipated cost of compliance for an impacted entity to comply with the rule is \$220 to \$264 per person, depending on administrative and staffing variables. There is no additional cost as a result of the rule amendment.

5101:2-5-13

- a. Agencies must have agency policies as required by this rule. Some agencies will not need to have a policy on everything as the policies are dependent on their certified functions.
- b. A social worker, administrators or a team of workers would be implementing the requirements of this rule. The current average wage for a social worker is \$22 per hour, according to Zip Recruiter. The anticipated time involved could be between 15-20 hours per person.
- c. Therefore, the anticipated cost of compliance for an impacted entity to comply with the rule is \$330 to \$440 per person, depending on administrative and staffing variables.

17. Why did the Agency determine that the regulatory intent justifies the adverse impact

To ensure the safety of children in substitute care, the adverse impact of these rules is necessary.

Regulatory Flexibility

18. Does the regulation provide any exemptions or alternative means of compliance for small businesses? Please explain.

For rules 5101:2-5-02, 5101:2-5-03, 5101:2-5-04, and 5101:2-5-13, there are no apparent alternative means of compliance or possible exemptions given the nature of the rules.

19. How will the agency apply Ohio Revised Code section 119.14 (waiver of fines and penalties for paperwork violations and first-time offenders) into implementation of the regulation?

For rules 5101:2-5-02, 5101:2-5-03, 5101:2-5-04, and 5101:2-5-13, there are no fines or civil penalties for non-compliance other than the forfeiture of certification through denial or revocation. Section 119.14 is not applicable in this instance.

20. What resources are available to assist small businesses with compliance of the regulation?

ODJFS has regional offices with licensing specialists assigned to each agency to assist in the obtaining and maintaining compliance. Specialists are available to provide technical assistance to meet the requirements of all regulations.
