### **Business Impact Analysis**

The Common Sense Initiative is established in R.C. 107.61 to eliminate excessive and duplicative rules and regulations that stand in the way of job creation. Under the Common Sense Initiative, agencies must balance the critical objectives of regulations that have an adverse impact on business with the costs of compliance by the regulated parties. Agencies should promote transparency, responsiveness, predictability, and flexibility while developing regulations that are fair and easy to follow. Agencies should prioritize compliance over punishment, and to that end, should utilize plain language in the development of regulations.

#### **Regulatory Intent**

**OAC rule 5101:2-42-18.1** entitled **Non-Discrimination Requirements for Foster Care Placements** explains that race, color, or national origin (RCNO) may not be considered in the placement process for foster care placement. It outlines that what is prohibited and permitted in when selecting a foster care placement. It also details the steps that need to be taken should RCNO become a compelling factor in the placement process. In paragraph (J)(2) language was edited to comply with the CSI project to identify outdated Ohio Administrative Code methods of communication and ORC terms that require in-person interaction. The revisions dates for forms were removed throughout.

**OAC rule 5101:2-48-13** entitled **Non-Discrimination Requirements for Adoptive Placements** explains that RCNO may not be considered in the placement process for an adoptive placement. It outlines that what is prohibited and permitted in when selecting an adoptive placement. It also details the steps that need to be taken should RCNO become a compelling factor in the placement process. Paragraph (F) was replaced, as the requirements were obsoleted per Procedure Letter No. 325 in January 2018. In paragraph (M)(2) language was edited to comply with the CSI project to identify outdated Ohio Administrative Code methods of communication

and ORC terms that require in-person interaction. The term "SACWIS" was changed to "Ohio SACWIS." The revisions dates for forms were removed throughout.

4. Does the regulation implement a federal requirement? Is the proposed regulation being adopted or amended to enable the state to obtain or maintain approval to administer and enforce a federal law or to participate in a federal program? *If yes, please briefly explain the source and substance of the federal requirement.* 

Rules 5101:2-42-18.1 and 5101:2-48-13 do implement the Multiethnic Placement Act, Oct. 20, 1994, P.L. 103-382, as amended by Section 1808 of the Small Business Job Protection Act of 1996, Aug. 20, 1996, P.L. 104-188 (MEPA), and the Civil Rights Act of 1964 (Title VI).

The federal law prohibits delay or denial of the placement of a child for adoption or foster care on the basis of race, color, or national origin of the adoptive or foster parent, or the child involved. Both rules outline the process that must be undertaken should RCNO become a compelling factor in the placement decision-making process.

5. If the regulation includes provisions not specifically required by the federal government, please explain the rationale for exceeding the federal requirement.

These rules do not exceed federal requirements.

6. What is the public purpose for this regulation (i.e., why does the Agency feel that there needs to be any regulation in this area at all)?

The rules, which are promulgated pursuant to the requirements of the Revised Code, establish regulations for the minimum standards to ensure the safety and well-being of children being placed in foster and adoptive homes.

These rules ensure that foster and adoptive parents are not discriminated against based on race, color, or national origin, which is in the best interest of children. It also provides guidance to agencies on adhering to the federal requirements of the Multiethnic Placement Act. This rule helps to ensure that children's needs are considered individually.

No. ODJFS did not consider a performance-based initiative, but rather followed statutory language prescribing that the department set minimum standards to ensure the safety and well-being of all children being placed and all families that receive services.

There are no duplications as the rules are specific to foster care and adoption agencies and no other rules address these specific issues. These rules have been reviewed by the Partners for Ohio's Families Rule Review Board for duplication and approval, as well as the legal staff at ODJFS prior to the clearance process to ensure they do not duplicate any existing Ohio regulations.

ODJFS licensing specialists and technical assistance specialists monitor agencies to ensure the regulations are applied consistently.

The rules also ensure that placement is not delayed due to discrimination based upon race, color, and national origin. Most importantly, the rules ensure the individual needs of the child are being assessed to meet their needs.
