Regulatory Intent

2. Please briefly describe the draft regulation in plain language.

Please include the key provisions of the regulation as well as any proposed amendments.

The department has drafted the amendments proposed in this rule package to assist with consistency between Administrative Code and Revised Code. Since the last revision of the rules, the Revised Code has been amended by House Bill 506 in 2018 and House Bill 166 in 2019. House Bill 506 revised multiple sections of Chapter 956 of the Revised Code to revise the law governing high volume dog breeders and other dog-related professionals and facilities. House Bill 166, commonly known as the FY 2020-2021 Operating Budget, amended sections 956.01, 956.031, 956.051, and 956.20 of the Revised Code. Both House Bills initiated the large number of changes necessary in this proposed rule package.

Rule 901:1-5-12 outlines testing standards of Brucella canis and acceptable types of tests as well as the entities which may perform the tests. Further, the rule outlines three types of Brucella canis classification. The rule is being amended to allow for the card test to be used, change requirements for identification and reporting, and LSC required changes.

Rule 901:1-6-01 establishes the definitions and general considerations for this chapter of the Administrative Code. The rule is being amended to add new definitions and amend existing definitions.

Rule 901:1-6-02 establishes housing standards for dogs kept by high volume breeders. The rule is being amended in the primary enclosure paragraphs, add new requirements for the primary enclosure size and flooring paragraphs, and remove no longer necessary paragraphs.

Rule 901:1-6-03 establishes socialization standards for dogs kept by high volume breeders. The rule is being amended to add daily exercise requirements and add requirements for safely accessing the outdoors.

Rule 901:1-6-04 establishes food and water standards for dogs kept by high volume breeders. The rule is being amended to further clarify requirements for food and water.

Rule 901:1-6-05 establishes health standards for dogs kept by high volume breeders. The rule is being amended further clarify the requirements for the health of adult dogs and puppies kept by high volume breeders. The rule is also amended to remove paragraphs that are no longer necessary.

Rule 901:1-6-06 establishes transportation standards for dogs kept by high volume breeders. The rule is being proposed as rescinded.

Rule 901:1-6-07 establishes recordkeeping standards for all dogs regulated under Chapter 956 of the Revised Code. The rule is being amended in the paragraphs pertaining to identification of the dogs and in the paragraphs requiring recordkeeping. The rule is amended to remove paragraphs that are no longer necessary.

Rule 901:1-6-08 sets forth the licensing application form and procedure for high volume breeders and dog brokers, and the registration requirements for animal rescues for dogs. The rule is being amended to establish licensing requirements as based on the facility type.

Rule 901:1-6-09 establishes the procedures for inspections conducted under section 956.10 of the Revised Code. The rule is being amended to remove an unnecessary word.

Rule 901:1-6-10 establishes civil penalties for operating as a high volume breeder or dog broker without a license. The rule is being proposed as rescinded and then new due to the high amount of change.

Rule 901:1-8-01 outlines the definitions used in Chapter 901:1-8. The rule is being amended to provide additional clarification to existing definitions.

Rule 901:1-8-02 sets forth the licensing procedures for pet stores in the state of Ohio. The rule is being amended to remove the licensing fee which is located in Revised Code and a LSC stylistic change.

Rule 901:1-8-03 outlines the microchip requirements for all dogs displayed, offered for sale, delivered, bartered, auctioned, brokered, given away, transferred, or sold by a pet store. The rule is being amended to include dog brokers in the requirement for identification.

Rule 901:1-8-04 outlines the recordkeeping requirements of pet stores. The rule is being amended to require the length of time and location of records to be kept by pet stores.

Rule 901:1-8-05 outlines the recordkeeping requirements of dog brokers. The rule is being amended to require the address of the physical location of the supplier of the dog to be kept by dog brokers.

- 6. What is the public purpose for this regulation (i.e., why does the Agency feel that there needs to be any regulation in this area at all)?

The Department is required to adopt the rules in accordance with Chapter 956 of the Revised Code to promote appropriate animal care. The Department is required to maintain standards of care for dogs kept by high volume dog breeders, as well as licensing requirements and procedures for high volume dog breeders, pet stores, and dog brokers. The Department is directed to adopt rules regarding inspections, records, and requirements regarding the payments of sales tax by high volume breeders and dog broker. Animal rescues are required by statute to register with the Department in accordance with the rules.

7. How will the Agency measure the success of this regulation in terms of outputs and/or outcomes?

The Department will measure success by compliance with the license and registration requirements, and through adherence to the care standards as measured by both annual inspections and complaint driven inspections.

10. What input was provided by the stakeholders, and how did that input affect the draft regulation being proposed by the Agency?

During the first stakeholder outreach comment period, the Department received comments regarding the changes made to the removal of dewclaws and tail docking, fly mitigation program, the definition of access the outdoors, and the Brucella canis approved testing methods. In response to received comments, the Department amended the rules to require tail docking to be performed by a licensed veterinarian and all suggested rule language regarding a fly mitigation program was incorporated. The Department amended the definition of access the outdoors to achieve consistency with the Ohio Revised Code. The Brucella canis card test

was added to the list of approved testing methods to increase surveillance and reporting of this zoonotic disease.

11. What scientific data was used to develop the rule or the measurable outcomes of the rule? How does this data support the regulation being proposed?

The United States Department of Agriculture regulations regarding the housing of dogs served as the starting point in drafting the original regulations. The proposed amended rules include input from veterinarians, members of the public, humane agents, animal rescue workers, dog breeders, and other interested parties.

12. What alternative regulations (or specific provisions within the regulation) did the Agency consider, and why did it determine that these alternatives were not appropriate? If none, why didn't the Agency consider regulatory alternatives?

Alternative regulations for this industry were not considered due to the prescriptive nature of the Ohio Revised Code. Furthermore, standards for the care of animals and equal opportunity for individuals entering the industry prohibit the use of alternative regulations.

13. Did the Agency specifically consider a performance-based regulation? Please explain. Performance-based regulations define the required outcome, but don't dictate the process the regulated stakeholders must use to achieve compliance.

These rules are not performance based due to the nature of the regulated industry. This rule package is primarily the standards of care for high volume breeders and by necessity these rules provide minimum standards of how breeders are to conduct their business.

14. What measures did the Agency take to ensure that this regulation does not duplicate an existing Ohio regulation?

The Department has sole regulatory authority over this area of industry.

15. Please describe the Agency's plan for implementation of the regulation, including any measures to ensure that the regulation is applied consistently and predictably for the regulated community.

The Department intends to provide educational outreach programs to educate the industry regarding the changes to the regulations. The Department also provides copies of the Ohio Revised Code and Ohio Administrative Code, as it pertains to the industry, with all new and renewal license applications. The administrative and field staff within the Animal Health division are also available for guidance to all industry members. The Animal Health division meets on a weekly basis to ensure consistency and predictability throughout the state for the regulated community.

Adverse Impact to Business

All pet stores, dog brokers, and high volume dog breeders must submit a completed application along with the appropriate license fee to be considered a complete application in compliance with section 956.07 or 956.21 of the Revised Code. The rules require specific information and documents to be recorded and maintained. These records must be made available upon request.

c. Quantify the expected adverse impact from the regulation.

The adverse impact can be quantified in terms of dollars, hours to comply, or other factors; and may be estimated for the entire regulated population or for a "representative business." Please include the source for your information/estimated impact.

For tail docking to be performed by a licensed veterinarian, a regulated business will incur an increase in veterinary expenses. This increase in expenses will be dependent on the breed of the puppy, each veterinary clinic's pricing, and the number of puppies per year.

Regarding primary housing changes, industry will potentially need to reconstruct cage layout. This expense will directly relate to the size of the high volume breeder operation and current facility layout. Construction costs will be dependent on the contractor, building materials, and industry time involved will vary by facility.

17. Why did the Agency determine that the regulatory intent justifies the adverse impact to the regulated business community?

The intentions of the proposed regulations are to provide regulatory framework for the standards of care for dogs and equal opportunities to those engaged in the regulated community. The adverse impacts are considered justified based on consistent regulation throughout the state of Ohio for this industry.

Regulatory Flexibility

18. Does the regulation provide any exemptions or alternative means of compliance for small businesses? Please explain.

Chapter 956 of the Revised Code does not grant an exemption or alternative means of compliance for small businesses.

19. How will the agency apply Ohio Revised Code section 119.14 (waiver of fines and penalties for paperwork violations and first-time offenders) into implementation of the regulation?

The department works with violators to educate them to correct any potential future violations.

20. What resources are available to assist small businesses with compliance of the regulation?

The department has online resources and field staff available to provide assistance.
