The Common Sense Initiative is established in R.C. 107.61 to eliminate excessive and duplicative rules and regulations that stand in the way of job creation. 4751-1-02: Revised to eliminate the “temporary” license language as per statute

4751-1-03: Revised to remove the word “all” to allow the board secretary flexibility for emergencies

4751-1-04: Revised to allow for individuals to request approved meeting minutes by phone or email

4751-1-05: Revised to eliminate unnecessary language, e.g. “if the board approves a fourth time”

4751-1-09: Revised to update language to match current practice, allow the board more time to process applications before a meeting, update where AITs can find a required form, include attendance at a new board AIT/Preceptor training course, remove unnecessary language

4751-1-10: Revised to reflect a statute change eliminating the board’s temporary license and enacting a new provision, and a statute change of the license renewal period from 1 year to every 2 years

4751-1-10.1: Revised to update language to match current practice, a statute change of the license renewal requirement from every year to every 2 years, and removal of a notary requirement

4751-1-10.2: Revised to implement a statutory change of license renewal periods from every year to every 2 years

4751-1-10.3: Revised to implement a statutory change eliminating the board's temporary license and reflect every 2-year renewal

4751-1-12: Revised to eliminate language referring to a temporary license and every 2 year renewal

4751-1-12.2: New rule to outline the prehearing process

4751-1-13: Revised to implement a statutory change from every year license renewal to every 2 year renewal and update language to reflect current practice. Also revised to allow for all required CEs to be obtained online/self-study/distance learning.

4751-1-14: Revised to comply with statutory change on recognizing an out-of-state license and granting a license to practice in Ohio

4751-1-16: Revised to comply with statutory changes to remove the temporary license fee and change the annual license renewal fee to a biannual license renewal fee

Development of the Regulation

The Board posted draft copies of the rules on the Board’s website from March 6, 2023 through March 27, 2023 for an early stakeholder outreach period. The initial public comment period is set to run from 3-28-2023 through 4-11-23. All three of the primary provider associations (LeadingAge Ohio, The Ohio Health Care Association, and the Academy of Senior Health Services) placed a notice in their newsletters (emailed to all members) including a link to the draft rules on the Board’s website, and an eblast was sent to all licensees.

The JCARR standard for invalidation has been an ongoing deterrent to duplication. Legal staff, the Board, and Board Committees (where appropriate) have reviewed rules to assure there is no duplication of an existing Ohio regulation.

BELTSS will once again seek the assistance of the three primary provider associations (as described in question number 7) to help distribute the updated rules to its members and drive traffic to the website where the updated rules will be posted. An email blast will also be sent to licensees and interested parties to inform them of the changes.

The scope of the impacted business community is all licensed nursing home administrators, administrators-in-training, and nursing facilities.

The estimated adverse impact of these regulations is the time required to carefully read the instructions for how licensees are to renew going forward, probably 15-20 minutes. Nursing homes will have the burden of requesting a 180-day license in case of emergencies; that burden has shifted from the individual to the nursing home, but the individual will still have to do the paperwork. Estimated 15 minutes time for the nursing home and an hour for the LNHA.

16. Are there any proposed changes to the rules that will reduce a regulatory burden imposed on the business community? Please identify. (*Reductions in regulatory burden may include streamlining reporting processes, simplifying rules to improve readability, eliminating requirements, reducing compliance time or fees, or other related factors*).

Allowing an individual to call or email to receive approved board minutes instead of just sending a letter will be easier on the individual. The requirement to attend the AIT/preceptor virtual training course should make it easier for preceptors and AITs to follow the rules and successfully complete the training period. Every other year renewal will save the administrators a little time on the years they do not have to renew.

17. Why did the Agency determine that the regulatory intent justifies the adverse impact to the regulated business community?

These rules are driven by statutory change that the board is obligated to comply with.
