The Common Sense Initiative is established in R.C. 107.61 to eliminate excessive and duplicative rules and regulations that stand in the way of job creation. Under the Common Sense Initiative, agencies must balance the critical objectives of regulations that have an adverse impact on business with the costs of compliance by the regulated parties. Agencies should promote transparency, responsiveness, predictability, and flexibility while developing regulations that are fair and easy to follow. Agencies should prioritize compliance over punishment, and to that end, should utilize plain language in the development of regulations.

Reason for Submission

Regulatory Intent

OAC 5101:2-5-20 entitled Initial application and completion of the foster care homestudy provides guidance to agencies on the application and homestudy process for a foster care applicant. Paragraph (E)(4) was added to provide reference to the new sections Ohio Revised Code 2131.03, 2131.031, 2131.032, 2131.033 which were created to address persons with disabilities and modifications that may be necessary to accommodate them when applying as a foster caregiver. Paragraphs (K)(3) and (N)(3) have Ohio added to the name of the statewide automated child welfare information system (SACWIS), to properly identified the system as Ohio SACWIS.

OAC 5101:2-48-12 entitled Completion of the Adoption Homestudy provides guidance to agencies on the homestudy process for prospective adoptive applicants. Paragraph (E)(4) was added to provide reference to the new sections Ohio Revised Code 2131.03, 2131.031, 2131.032, 2131.033 which were created to address persons with disabilities and modifications that may be necessary to accommodate them when applying as an adoptive parent. Paragraph (D) corrected spelling of word 'conflict'.

These rules do not exceed any Federal requirements.

6. What is the public purpose for this regulation (i.e., why does the Agency feel that there needs to be any regulation in this area at all)?

Both rules amended are a result of the general rule writing authority regarding the safety of children in care as directed in section 5103.03 paragraph (A) of the Revised Code.

For rule 5101:2-5-20, the purpose of the regulation is to provide guidance on the completion of a foster care homestudy.

For rule 5101:2-48-12, the purpose of the regulation is to provide guidance on the completion of an adoption homestudy.

7. How will the Agency measure the success of this regulation in terms of outputs and/or outcomes?

Rules 5101:2-5-20 and 5101:2-48-12 will be measured against the criteria specific to the rule content. Licensing specialists will monitor compliance ensuring the health and safety of children in care and preventing those who are ineligible/prohibited to provide care.

Development of the Regulation

9. Please list the stakeholders included by the Agency in the development or initial review of the draft regulation.

ODJFS presented at the Public Children Services Association of Ohio (PCSAO) on June 1, 2023, the Ohio Children's Alliance (OCA) committee on foster care and adoption on June 20, 2023, and the Ohio Adoption Planning Group (OAPG) on May 17, 2023, regarding the proposed rule changes.

The rules went through the public clearance process on June 20, 2023, through July 4, 2023.

10. What input was provided by the stakeholders, and how did that input affect the draft regulation being proposed by the Agency?

There were no comments received from stakeholders regarding the rules presented at PCSAO, OCA or OAPG meetings. There were two external comments received did not impact the draft regulation proposed, as both of the comments referenced issues with Ohio Revised Code and not the Ohio Administrative Code.

11. What scientific data was used to develop the rule or the measurable outcomes of the rule? How does this data support the regulation being proposed?

Not applicable.

12. What alternative regulations (or specific provisions within the regulation) did the Agency consider, and why did it determine that these alternatives were not appropriate? If none, why didn't the Agency consider regulatory alternatives? Alternative regulations may include performance-based regulations, which define the required outcome, but do not dictate the process the regulated stakeholders must use to comply.

There were no other alternatives considered for the rules as requirements are driven by statute.

13. What measures did the Agency take to ensure that this regulation does not duplicate an existing Ohio regulation?

There is no duplication as the rules are specific to foster care and adoption agencies and no other rules address these specific issues. These rules were reviewed by the legal staff at ODJFS to ensure they do not duplicate any existing Ohio regulations.

14. Please describe the Agency's plan for implementation of the regulation, including any measures to ensure that the regulation is applied consistently and predictably for the regulated community.

ODJFS licensing specialists review the agencies to ensure the regulations are applied consistently and they offer technical assistance in areas of inconsistency.

Adverse Impact to Business

- a. Scope of impacted business community:
 - The rules included in this BIA contain requirements for foster care and adoption agencies that include eighty-eight public and over one hundred private agencies. Requirements must be met in order to obtain and/or maintain certification or approval.
- b. Quantify and identify the nature of adverse impact:
 - The rules require the identification and provision of support services for a person with a disability through the application and homestudy of foster care and adoptive applicants. The adverse impact for each of the requirements would vary based upon the size and staffing of each agency and would include the actual cost of completing each requirement, in addition it involves the time and resources it takes for an agency to complete a homestudy. This would include the time to review the application and other documents submitted for the homestudy, the time to interview the applicants, as well as any other household members, complete a safety audit of the home, send in requests for abuse and neglect searches to be completed on adults in the home, send reference letters, and the time to communicate with the applicants regarding any additional documentation or concerns with the homestudy.

The current average wage for use in the examples below for a social worker is \$22 per hour, according to Zip Recruiter. However, the specific anticipated cost of compliance for an impacted agency to comply with this rule would vary, depending on administrative and staffing variables.

16. Are there any proposed changes to the rules that will <u>reduce</u> a regulatory burden imposed on the business community? Please identify. (Reductions in regulatory burden may include streamlining reporting processes, simplifying rules to improve readability, eliminating requirements, reducing compliance time or fees, or other related factors).

The proposed changes do not change what was is currently in place. The proposed changes only implements recent legislation which states that a person with a disability may need modifications made to accommodate that person applying to be a foster caregiver or adoptive parent.

17. Why did the Agency determine that the regulatory intent justifies the adverse impact to the regulated business community?

To ensure the safety of children in substitute care, the adverse impact of these rules is necessary.

Regulatory Flexibility

18. Does the regulation provide any exemptions or alternative means of compliance for small businesses? Please explain.

For rules 5101:2-5-20 and 5101:2-48-12, there are no apparent alternative means of compliance or possible exemptions given the nature of the rules.

19. How will the agency apply Ohio Revised Code section 119.14 (waiver of fines and penalties for paperwork violations and first-time offenders) into implementation of the regulation?

For rules 5101:2-5-20 and 5101:2-48-12, there are no fines or civil penalties for non-compliance other than the forfeiture of certification through denial or revocation.

20. What resources are available to assist small businesses with compliance of the regulation?

ODJFS has regional office with licensing specialists assigned to each agency to assist in the obtaining and maintaining compliance. Specialists are available to provide technical
