OAC 5101:2-5-27 entitled Agency procedure for the termination of a foster home certificate provides guidance to agencies on the process for terminating the certification of a foster caregiver. This rule is being introduced as a no change rule.

OAC 5101:2-5-29 entitled Agency requirements for foster home records provides guidance to agencies on the information that is to be included in the records of a foster home. This rule is being introduced as a no change rule.

OAC 5101:2-5-36 entitled Additional requirements for that acts as a representative of ODJFS in recommending treatment foster homes for certification provides guidance to agencies on the required qualifications and additional guidelines for treatment foster homes. This rule is being introduced as a no change rule.

OAC 5101:2-5-37 entitled Additional requirements for that acts as a representative of ODJFS in recommending medically fragile foster homes for certification provides guidance to agencies on the required qualifications and additional guidelines for medically fragile foster homes. This rule is being introduced as a no change rule.

OAC 5101:2-33-80 entitled Retained applicant fingerprint database information exchange (“Rapback”) provides guidance to agencies on the criminal record data exchange for foster caregivers and employees. This rule is being introduced as a no change rule.

Yes. For rule 5101:2-33-80, background checks for foster caregivers and employees are required by SEC. 471. [42 U.S.C. 671] (a) (20) of the Social Security Act.

These rules do not exceed any federal requirements.

These rules are a result of the general rule writing authority regarding the safety of children in care as directed in section 5103.03 paragraph (A) of the Revised Code.

For rule 5101:2-5-27, the purpose of the regulation is to provide guidance to agencies on the process for terminating the certification of a foster caregiver.

For rule 5101:2-5-29, the purpose of the regulation is to provide guidance on the information that is to be included in the records of a foster home.

For rule 5101:2-5-36 the purpose of the regulation is to provide guidance on the required qualifications and additional guidelines for treatment foster homes.

For rule 5101:2-5-37, the purpose of the regulation is to provide guidance on the required qualifications and additional guidelines for medically fragile foster homes.

For rule 5101:2-33-80, the purpose of the regulation is to provide guidance on the criminal record data exchange for foster caregivers and employees.

7. How will the Agency measure the success of this regulation in terms of outputs and/or outcomes?

Rules 5101:2-5-27, 5101:2-5-29, 5101:2-5-36, 5101:2-5-37 and 5101:2-33-80 will be measured against the criteria specific to the rule content. Licensing specialists will monitor compliance ensuring the health and safety of children in care and preventing those who are ineligible/prohibited to provide care.

Development of the Regulation

Alternative regulations may include performance-based regulations, which define the required outcome, but do not dictate the process the regulated stakeholders must use to comply.

There were no other alternatives considered for the rules as requirements are driven by statute.

- 13. What measures did the Agency take to ensure that this regulation does not duplicate an existing Ohio regulation?**

There is no duplication as the rules are specific to foster care agencies and no other rules address these specific issues. These rules were reviewed by the legal staff at ODJFS to ensure they do not duplicate any existing Ohio regulations.

- 14. Please describe the Agency's plan for implementation of the regulation, including any measures to ensure that the regulation is applied consistently and predictably for the regulated community.**

ODJFS licensing specialists review the agencies to ensure the regulations are applied consistently and they offer technical assistance in areas of inconsistency.

Adverse Impact to Business

- a. Scope of impacted business community:
The rules included in this BIA contain requirements for foster care and adoption agencies that include eighty-eight public and over one hundred private agencies. Requirements must be met in order to obtain and/or maintain certification or approval.
- b. Quantify and identify the nature of adverse impact:

The rules require the agency to keep records for foster caregivers and the certification of treatment and medically fragile foster caregivers. They also require the agency to follow the proper procedure for the termination of a foster care certificate and for the processing of alerts from the Rapback system. The adverse impact for each of the requirements would vary based upon the size and staffing of each agency and would include the actual cost of completing each requirement, in addition it involves the time and resources it takes for an agency to terminate a caregiver's certificate, keep a caregivers record and certify a treatment and medically fragile caregiver. This would include the time to review the information necessary for the termination of a certificate, the time needed for ~~the~~ keeping the records and the time involved in certifying a treatment or medically fragile caregiver and the time involved in reviewing the alerts from the Rapback system.

The current average wage for use in the examples below for a social worker is \$22 per hour, according to Zip Recruiter. However, the specific anticipated cost of compliance for an impacted agency to comply with these rules would vary, depending on administrative and staffing variables.

16. Are there any proposed changes to the rules that will reduce a regulatory burden imposed on the business community? Please identify. (*Reductions in regulatory burden may include streamlining reporting processes, simplifying rules to improve readability, eliminating requirements, reducing compliance time or fees, or other related factors*).

The proposed changes do not change what ~~was~~ is currently in place as these rules are being filed as no change rules.

17. Why did the Agency determine that the regulatory intent justifies the adverse impact to the regulated business community?

To ensure the safety of children in substitute care, the adverse impact of these rules is necessary.

Regulatory Flexibility

18. Does the regulation provide any exemptions or alternative means of compliance for small businesses? Please explain.

For rules 5101:2-5-27, 5101:2-5-29, 5101:2-5-36, 5101:2-5-37 and 5101:2-33-80 , there are no apparent alternative means of compliance or possible exemptions given the nature of the rules.

19. How will the agency apply Ohio Revised Code section 119.14 (waiver of fines and penalties for paperwork violations and first-time offenders) into implementation of the regulation?

For rules 5101:2-5-27, 5101:2-5-29, 5101:2-5-36, 5101:2-5-37 and 5101:2-33-80 , there are no fines or civil penalties for non-compliance other than the forfeiture of certification through denial or revocation.

ODJFS has regional office with licensing specialists assigned to each agency to assist in the obtaining and maintaining compliance.
