Public Notice Proposed Rulemaking Governing Construction and Demolition Debris Co-Located Processing Facility Rules

The purpose of this rule making is to fulfill the requirements of Senate Bill 2 of the 132nd Ohio General Assembly, which required the director to adopt rules for construction and demolition debris processing facilities to ensure that the facilities will not create a nuisance, fire hazard, or health hazard or cause or contribute to air or water pollution. These rules pertain to C&DD "co-located" processing facilities, which are located wholly within the facility boundary of a licensed construction and demolition debris facility, as that boundary is identified in the effective construction and demolition debris facility license.

The public comment period will run until May 25, 2022. A public hearing on this proposed rule making will be held to consider public comments in accordance with Section 119.03 of the Ohio Revised Code.

Ohio EPA will be holding virtual public hearing on the rules on May 25, 2022 at 10:30 a.m. During the hearing, the public may submit written comments on the record about the proposed rules that will be read into the record by the hearing host.
