## Public Notice Proposed Rulemaking Governing Solid Waste Incinerator and Solid Waste Energy Recovery Facility Rules

Notice is hereby given that the Director of Environmental Protection, under the authority of Sections 3734.02, 3734.021, and 3734.73 of the Ohio Revised Code and in accordance with Chapter 119 of the Ohio Revised Code, proposes to original file the following rules of the Ohio Administrative Code:

These rules provide the procedures for the construction, operation, and closure of solid waste incinerators and solid waste energy recovery facilities. DMWM has determined that minimal programmatic changes to bring the rules in compliance with the Legislative Service Commission's and Ohio EPA's rule drafting standards are necessary and has also relocated the rules into their own Ohio Administrative Code chapter, consistent with DMWM's effort to re-organize all of its rules, to allow for better readability.

The public comment period will run until October 26, 2022. A public hearing on this proposed rule making will be held to consider public comments in accordance with Section 119.03 of the Ohio Revised Code. Ohio EPA will be holding an in-person and virtual public hearing on the rules on October 26, 2022 at 1:00 pm. The in-person hearing will be at the same time and date and will be located at Ohio EPA, Suite 700, 50 W. Town Street, Columbus, Ohio 43215. During the hearing, the public may submit written comments on the record about the proposed rules if participating virtually and verbally if participating in person.

Oral testimony may be limited to five minutes, depending on the number of persons testifying. All interested persons are entitled to attend or be represented and to present oral and/or written comments concerning the proposed rule making.
