### PUBLIC NOTICE

The Ohio State Racing Commission will hold a public hearing for the purpose of accepting testimony on the proposed no change and amended rule package containing rules found in Chapter 3 and the rescission of chapter 18 of the Ohio Administrative Code.

These rules discuss wagering . These rules were reviewed in accordance with the requirements of Ohio Revised Code 119.03 and have been proposed as follows:

- Chapter 3 no change rules Ohio Administrative Code 3769-3-01, 3769-3-06 through 3769-3-1; 3769-3-12 through 3769-18; 3769-3-22; 3769-3-24 through 3769-3-27; 3769-3-30; 3769-3-36; 3769-3-38; and 3769-3-40.
- Chapter 3 amended rules Ohio Administrative Code 3769-3-02 through 3769-3-05; 3769-2-11; 3769-3-19; 3769-3-20; 3769-3-21; 3769-3-23; 3769-3-28; 3769-3-32 through 3769-3-35; 3769-3-37; 3769-3-39; and 3769-3-99 The se rules were broadened to include both breeds as a result of rescinding Chapter 13, and to remove regulatory restriction.
- Chapter 13 rescission of rules Ohio Administrative Code 3769-13-01 through 3769-13-28; 3769-13-30; 3769-13-32 through 3769-13-40; and 3769-13-99 This chapter is being rescinded due to being duplicative with Chapter 3.
