Public Notice Proposed Rulemaking Governing Municipal Solid Waste Landfill Operational Rules

Notice is hereby given that the Director of Environmental Protection, under the authority of Sections 3714.02, 3714.02, 3714.09, 3734.02, 3734.021, 3734.12, 3734.041, 3734.57, 3734.70, 3734.71, 3734.72, 3734.73, 3734.74 of the Ohio Revised Code (ORC) and in accordance with ORC Chapter 119, proposes to original file the following rule of the Ohio Administrative Code:

Ohio Administrative Code rule 3745-27-19 contains operational specifications for owners and operators of municipal solid waste landfills and is currently due for a five-year review pursuant to Ohio Revised Code section 106.03. Ohio Administrative Code rule 3745-27-15 contains financial assurance specifications, and Ohio Administrative Code rule 3745-500-02 contains solid waste definitions.

The purpose of this rule making is to satisfy the requirements of Ohio Revised Code section 106.03. As part of this rulemaking effort, Ohio EPA re-organized the municipal solid waste landfill operational rule into a new program chapter in Ohio Administrative Code Chapter 3745-535 and rescinded the existing rule in Ohio Administrative Code Chapter 3745-27. This proposed rulemaking effort aims to make the requirements clearer and easier to navigate.

The public comment period will run until January 5, 2024. A public hearing on this proposed rulemaking will be held to consider public comments in accordance with Section 119.03 of the Ohio Revised Code. Ohio EPA will be holding an in-person and virtual public hearing on the rules on January 5, 2024, at 10:30 a.m. During the hearing, the public may submit written comments on the record about the proposed rules and, if participating in person, may provide comments verbally.

Oral testimony may be limited to five minutes, depending on the number of persons testifying. All interested persons are entitled to attend or be represented and to present oral and/or written comments concerning the proposed rule making.

Written testimony will receive the same consideration as oral testimony. Written comments submitted after this date may be considered as time and circumstances permit.
