

## *PUBLIC HEARING NOTICE*

Pursuant to Ohio Revised Code Section 119.03, notice is hereby given that the Department of Administrative Services intends to conduct a public hearing for the purpose of amending or rescinding Ohio Administrative Code Sections 123:1-9-01 through 123:1-9-03, 123:1-25-01 through 123:1-25-07, and 123:1-27-04 through 123:1-27-05.

The rules proposed for amendment or rescinding deal with the following subject matter:

- 123:1-9-01 Examination guidelines.
- 123:1-9-02 Subjects, weights, and pass point.
- 123:1-9-03 Medical or psychological examination as a requirement for appointment to the classified service.
- 123:1-25-01 Transfers and intra-transfers in classified service.
- 123:1-25-02 Reinstatements after resignation.
- 123:1-25-04 Seasonal positions.
- 123:1-25-07 Temporary reassignment of duties.
- 123:1-27-04 General principles of the employee recognition program.
- 123:1-27-05 Employee recognition award.

The Department of Administrative Services shall hold a public hearing on the proposed rule amendment on Tuesday, June 18, 2024, at 9:00 a.m. in the 3<sup>rd</sup> Floor Administrative Hearing Room of the Rhodes Tower located at 30 East Broad St., Columbus, Ohio 43215. At this hearing, any person affected by the rule may appear and be heard in person, by the person's attorney, or both; may present the person's position, arguments, or contentions orally or in writing; offer and examine witnesses; and present evidence that tends to show that the rule, if effectuated, will be unreasonable or unlawful.
