#### RULES

#### 1301:16-1-02 – Open public meeting

The intent of this regulation is to set forth the procedure for providing public notice of a Board meeting.

The Ohio Real Estate Appraiser Board (Board) and Division staff recommends changes to the rule.

**Paragraphs A1 & A3** – The proposed amendments reflect the changes to the Division's mailing address and email address.

## **1301:16-1-03** – Criminal records check

The intent of this regulation is to establish the process of completing a criminal background check for each owner and controlling person of an applicant for Ohio appraisal management company license as required by Ohio Revised Code Section 4768.06.

The Board and Division staff recommends changes to the rule.

**Paragraph** A — The proposed amendments reflect the correct name of the state agency conducting criminal records checks.

## 1301:16-1-08 - Settlement agreements

The intent of this regulation is to establish the requirements for settlement agreements entered into by the Superintendent and an Ohio appraisal management company licensee that has been charged with violating license law.

The Board and Division staff recommends changes to the rule.

Paragraphs (B)(5), (B)(9), (D) & (E) – The amendments are proposed to ensure correct punctuation appears in the rule.

#### 1301:16-1-09 – Informal mediation meeting accommodations

The intent of this regulation is to establish the procedure associated with an informal mediation affecting Ohio appraisal management company licensees.

The Board and Division staff recommends changes to the rule.

**Paragraph** (C) – The amendment is proposed to ensure correction punctuation appears in the rule.

**Paragraph** (D) – The amendment is proposed to remove an incorrect citation.
