SUMMARY:

- Administrative rules in chapter 1501:7 are being amended to update the transition of program management from the division of water to the division of parks and watercraft.
- Administrative rules in chapter 1501:1-33 are being rescinded because they are obsolete.
- Administrative rule 1501:17-11-03 is being adopted to reinstate regulations for the operation of model aircraft and drones in natural areas and nature preserves.
- Administrative rule 1501:20-7-05 is being adopted to simplify the language related to the operation of snowmobiles and all purpose vehicles on trails designated for their use.
- Administrative rules 1501:20-1-02, 1501:20-3-01, 1501:20-3-02, 1501:20-5-01, 1501:20-5-02, 1501:20-7-01, 1501:20-7-02, 1501:20-7-03, 1501:20-7-04, 1501:20-7-05, 1501:20-7-06 are being rescinded because they are redundant.
- All other rules are being amended, or rescinded and replaced, for the purpose of revising terminology to comply with recently enacted changes to the Ohio Revised Code. These terminology changes do not substantially change the operation of the rules.

A public hearing on the proposed rule amendments will be held at 2:00 p.m. on Tuesday, May 14, 2024 in the A-2 conference room at ODNR Headquarters which is located at 2045 Morse Road in Columbus, Ohio.
