Public Notice Public Hearing Scheduled For Proposed Rulemaking Governing Water Quality Standards

Notice is hereby given that the Director of Environmental Protection, under the authority of Section 6111.041 of the Ohio Revised Code and in accordance with Chapter 119, proposes to amend the following water quality standards rules of the Ohio Administrative Code:

3745-1-10	Grand river drainage basin.
3745-1-13	Central Ohio tributaries drainage basin.
3745-1-14	Ashtabula river drainage basin.
3745-1-24	Muskingum river drainage basin.
3745-1-27	Black river drainage basin.
3745-1-28	Vermilion river drainage basin.

This rule addresses water quality standards regulations.

The purpose of this rule making is to complete the five-year rule reviews of six water quality standards rules as required by Ohio law, and to update these rules to reflect the latest scientific information.

The public comment period will run until June 6, 2024. A public hearing on this proposed rulemaking will be held to consider public comments in accordance with Section 119.03 of the Ohio Revised Code. Ohio EPA will be holding an in-person and virtual public hearing on the rules on June 6, 2024 at 10:30 a.m. The in-person hearing will be located in the Summer Conference Room at Ohio EPA, Suite 700, 50 W. Town Street, Columbus, Ohio 43215. During the hearing, the public may submit written or verbal comments on the proposed rules.

Oral testimony may be limited to five minutes, depending on the number of persons testifying. All interested persons are entitled to attend or be represented and to present oral and/or written comments concerning the proposed rule making.
