In accordance with Chapter 119 of the Revised Code, the Ohio Department of Agriculture will conduct a public hearing for the purpose of soliciting comments regarding the adoption, amendment and rescission of rules.

The public hearing will be from **10:00 am to 10:30 am** or until all parties in attendance have had the opportunity to be heard.

**The following rules are proposed for amendment:**

### **Farmland Preservation- Five Year Rule Review**

**OAC 901:2-01, 02, 04 through 12 and 14:** This rule package consists of twelve amended rules proposed as part of the statutory five-year review process.

### **Dairy Ch 3 Frozen Desserts- Five Year Rule Review**

**OAC 901:11-3-01 through 11:** This rule package consists of five amended rules, six rules to be rescinded and five new rules proposed as part of the statutory five-year review process.

### **Plant Health Noxious Weeds List- Five Year Rule Review**

**OAC 901:5-37-01:** This rule is being proposed as part of the statutory five-year review process with no changes made except to revise the statute that grants the rule writing authority to delete 901.10 because it is the incorrect statute.

### **Agreement for the Performance of Laboratory- Five Year Rule Review**

**OAC 901-15-01:** This rule package consists of one amended rule proposed as part of the statutory five-year review process.
