Pursuant to sections 5101.1414 and in accordance with Chapter 119 of the Ohio Revised Code, the Ohio Department of Children and Youth gives notice of the department's intent to consider the adoption and rescission of the rules as identified below and of a public hearing thereon.

The following OAC rules are being proposed for adoption and rescission as a result of a review conducted in accordance with section 106.03 of the Ohio Revised Code (ORC), which requires five-year reviews of all state agency rules. As a result of the five-year rule review and program updates, all rules in Chapter 5180:5-50 are being rescinded and replaced with three (3) new OAC rules, 5180:5-50-01 "Administration of bridges", 5180:5-50-02 "Eligibility for bridges", and 5180:5-50-03 "Title IV-E FCM program eligibility and reimbursability of bridges".

OAC 5180:5-50-01 entitled **Administration of bridges** outlines a definition of who may be a Bridges participant and how they may apply for Ohio's voluntary extended foster care program. This rule identifies the types of housing Bridges will financially support a young adult with as well as the checks that are completed on the living arrangement to ensure the safety of the participant. Activities that are completed while the young adult participates in the program such as assessments, face to face contacts, bridges plan and review, and credit reporting assistance are listed with timeframes for them to be completed. Lastly, this rule addresses the retention of records for the program and the ability for a young adult to obtain a summary of their services when requested. This is being adopted as a new rule.

OAC 5180:5-50-02 entitled **Eligibility for bridges** outlines the program eligibility criteria for a participant to apply, enroll and maintain services in Bridges with documentation that must be submitted for each step. The circumstances and process for a participant's withdrawal or termination from the program, and appeal rights are clarified through this rule. This is being adopted as a new rule.

OAC 5180:5-50-03 entitled **Title IV-E FCM program eligibility and reimbursability of bridges** describes under what circumstances a Title IV-E agency may extend foster care maintenance (FCM) payments, for administration, and training payments for Bridges participants. The details of how a young adult must voluntarily participate through a voluntary participation agreement, have a best interest court hearing and reside in an approved independent living setting to remain IV-E eligible are outlined. This is being adopted as a new rule.

OAC 5180:2-50-01 entitled **Bridges definitions** of the Administrative Code provides definitions for key terms used in the Bridges rules. All pertinent definitions were incorporated into the new rules if applicable. This rule is being rescinded.

OAC 5180:2-50-02 entitled **Requirements for bridges eligibility** of the Administrative Code outlines the eligibility requirements and application process for Bridges. This rule is being rescinded and incorporated in OAC rule 5180:5-50-01 and 5180:5-50-02.

OAC 5180:2-50-03 entitled **Bridges termination and reentry** of the Administrative Code outlines the reasons and process for terminating a participant from Bridges. This rule is being rescinded and incorporated in OAC rule 5180:2-50-02.

OAC 5180:2-50-04 entitled **Bridges Title IV-E eligibility and reimbursability determination** of the Administrative Code provides guidance on how Title IV-E eligibility and reimbursability are determined for a Bridges participant. This rule is being rescinded and incorporated in OAC rule 5180:2-50-03.

OAC 5180:2-50-05 entitled **Bridges appeal process** of the Administrative Code provides guidance on the appeals process when Bridges applicants or participants choose to appeal a denial or termination decision from Bridges. This rule is being rescinded and incorporated in OAC rule 5180:2-50-02.

OAC 5180:2-50-06 entitled **Bridges approved supervised independent living settings** and visitation requirements of the Administrative Code provides guidance on approved supervised independent living settings and visitation requirements for a Bridges participant. This rule is being rescinded and incorporated in OAC rule 5180:2-50-01.

OAC 5180:2-50-07 entitled **Bridges assessment, plan and review** of the Administrative Code provides guidance on assessments, plans, and reviews that are to be completed while a participant is enrolled in Bridges. This rule is being rescinded and incorporated in OAC rule 5180:2-50-01.

OAC 5180:2-50-08 entitled **Case records for bridges** of the Administrative Code provides guidance on case information retention for Bridges. This rule is being rescinded and incorporated in OAC rule 5180:2-50-01.
