The Ohio State Racing Commission will hold a public hearing for the purpose of accepting testimony on the proposed amended rule package containing rule(s) 3769-OAC 3769-2-01, 3769-2-03, 3769-2-10, 3760-2-14, 3769-2-18, 3769-2-23, 3769-2-24, 3769-2-35, and 3769-2-99 found in Chapter 2 of the Ohio Administrative Code.

These rules discuss Administrative Rules These rules were reviewed in accordance with the requirements of Ohio Revised Code 119.03 and have been proposed as follows:

- (1) Ohio Administrative Code 3769-2-01 titled The Commission, right to search This rule is being revised to comply with what will be 3769.031.
- (2) Ohio Administrative Code 3769-2-03 titled Procedure for adoption of rules This rule is being rescinded due to being duplicative.
- (3) Ohio Administrative Code 3769-2-10 titled File list of officials This rule is being revised to comply with what will be 3769.031.
- (4) Ohio Administrative Code 3769-2-14 titled Permit Holders enforcement obligations This rule is being revised to comply with what will be 3769.031.
- (5) Ohio Administrative Code 3769-2-18 titled Applications for licenses This rule is being revised to comply with what will be 3769.031.
- (6) Ohio Administrative Code 3769-2-23 titled License qualifications This rule is being revised to comply with what will be 3769.031.
- (7) Ohio Administrative Code 3769-2-24 titled License fees This rule is being revised to comply with what will be 3769.031.
- (8) Ohio Administrative Code 3769-2-35 titled Simulcasting of races This rule is being revised to comply with what will be 3769.031.
- (9) Ohio Administrative Code 3769-2-99 titled Penalties commission may impose. This rule is being revised to comply with what will be 3769.031.
