The following rules are proposed for amendment:

Division of Animal Health- Ch 24, Voluntary Animal Damage Control Plans-Five Year Rule Review

OAC 901:1-24-02: The rule is being amended to remove the appendix which ODA is proposing as a result of a statutory five-year rule review.

Division of Livestock Environmental Permitting- Ch 1 and 2, Five Year Rule Review

OAC 901:10-1-02, 03, 08, 09 and Appendix and 10; 901:10-2-01, 02 with Appendix, 04 with Appendix, 08, 10 with Appendix, 12, 13, 19 and 20: This rule package consists of fourteen amended rules which ODA is proposing as a result of a statutory five-year rule review.

Division of Animal Health- Ch 4, Dangerous Wild Animals and Restricted Snakes- Five Year Rule Review

OAC 901:1-4-01, 01.1, 01.3, 05, 09, 09, 10, 13, 15, 16 and 19: This rule package consists of ten amended rules which ODA is proposing as a result of a statutory five-year rule review.

Division of Plant Health- Ch 57 and 58, Quarantine Rules- Box Tree Moth and Asian Longhorned Beetle

OAC 901:5-57-05 and 901:5-58-04: This rule package consists of two amended rules which ODA is proposing as a result of revisions to the quarantine areas for the Box Tree Moth and the Asian Longhorned Beetle.
