Pursuant to sections 2151.421, 5103.03, 5153.166, and 5153.17 and in accordance with Chapter 119 of the Ohio Revised Code, the Ohio Department of Children and Youth gives notice of the department's intent to consider the recission and adoption to renumber rules as identified below and of a public hearing thereon.

The following OAC rules are being proposed for recission and adoption as a result of a review conducted in accordance with section 106.03 of the Ohio Revised Code (ORC), which requires five-year reviews of all state agency rules.

OAC rule 5180:2-38-02, entitled "Protective supervision by PCSAs", sets forth the PCSA's responsibilities when filing a complaint and complying with an order of protective supervision. It is being rescinded at its five-year rule review so that it can be renumbered to OAC rule 5180:3-7-02.

OAC rule 5180:2-38-03, entitled "Protective supervision by PCPAs", sets forth the PCPA's responsibilities when filing a complaint and complying with an order of protective supervision. It is being rescinded at its five-year rule review so that it can be renumbered to OAC rule 5180:3-7-03.

OAC rule 5180:2-38-06, entitled "Required contents if a PCPA case plan document", sets forth the required contents of the case plan developed by PCPA's. It is being rescinded at its five-year rule review so that it can be renumbered to OAC rule 5180:3-7-06.

OAC rule 5180:2-38-20, entitled "PCSA requirements for providing on-going services in alternative response." It sets forth the PCSA's requirements for case planning and review while providing on-going services in an alternative response case. It is being rescinded at its five-year rule review so that it can be renumbered to OAC rule 5180:3-7-20.

OAC rule 5180:3-7-02, entitled "Protective Supervision for PCSAs", is being adopted as a replacement for rescinded rule 5180:2-38-02. It outlines the responsibilities of the PCSA when filing a complaint and complying with an order for protective supervision. Paragraphs within the rule were restructured to question-and-answer format and condensed for clarity.

OAC rule 5180:3-7-03, entitled "Protective Supervision for PCPAs", is being adopted as a replacement for rescinded rule 5180:2-38-03. It outlines the responsibilities of the PCPA when filing a complaint and complying with an order of protective supervision. Paragraphs within the rule were restructured to question-and-answer format and condensed for clarity.

OAC rule 5180:3-7-06, entitled "Required contents if a PCPA case plan document", is being adopted as a replacement for rescinded rule 5180:2-38-06. It outlines the required contents of the case plan developed by PCPA's. Amendments to the rule

include changing the age for Independent Living requirements from 16 to 14 and paragraphs within the rule were restructured to question-and-answer format and condensed for clarity.

OAC rule 5180:3-7-20, entitled "PCSA requirements for providing on-going services in alternative response", is being adopted as a replacement for rescinded rule 5180:2-38-20. It outlines the requirements for case planning and review while providing on-going services in an alternative response case. Amendments to the rule include extending the Case Review completion requirements from once every 90 day to once every 180 days and changing the age for Independent Living from 16 to 14. Paragraphs within the rule were also restructured to question-and-answer format and condensed for clarity
