LEGAL NOTICE STATE OF OHIO OHIO DEPARTMENT OF MEDICAID

Pursuant to section 1902(a)(13)(A) of the Social Security Act, the director of the Ohio Department of Medicaid (department) gives final notice of the department's modification of provisions relating to the reimbursement of inpatient hospitals participating in the Medicaid program.

An initial notice was issued in November 2025 to inform the public of proposed changes in reimbursement to inpatient hospitals for Medicaid services. This final notice reflects the result of the public and legislative processes.

Ohio's biennial 2026/2027 budget enacted under Am. Sub. H.B. No. 96 of the 136th General Assembly included provisions to update reimbursement for inpatient hospital services. The department proposed increases to all in-state hospital peer group base rates, as well as per diem rates for free-standing psychiatric hospitals. Additionally, the department targeted increases to All-Patient Diagnostic Related Groups (APR-DRGs) relative weights to support efforts aimed at reducing maternal and infant mortality rates and expanded access to behavioral health services.
