109:2-11-02

Jailer training for five-day facilities.

(A) Who is required to complete jailer training.

- (1) Those persons set out in paragraph (F) of rule 109:2-11-01 of the Administrative Code shall complete the training prescribed in paragraph (B) of rule 5120:1-10-18 of the Administrative Code as follows and any other training prescribed by the executive director; during the first year of assignment shall include at least thirty-six hours of training in:
 - (a) "Minimum standards for jails in Ohio;"
 - (b) Correctional legal issues including inmate rights; official and personal liability, responsibility and rights;
 - (c) An overview of the criminal justice system;
 - (d) Jail security including admissions and release;
 - (e) Inmate and jail searches;
 - (f) Inmate supervision, surveillance, and discipline;
 - (g) Emergency responses;
 - (h) Recognition of abnormal inmate behavior including suicidal behavior; mental/emotional disorders and developmental disabilities; and substance abuse;
 - (i) Fire safety and response;
 - (j) Training in unarmed self-defense and first aid/CPR unless waived with current documentation of prior equivalent training.
- (2) Those persons set out in paragraph (G) of rule 109:2-11-01 of the Administrative Code shall complete the training prescribed in paragraph (E) of rule 5120:1-10-18 of the Administrative Code as follows and any other training prescribed by the executive director. During the first year of assignment shall include at least sixteen hours of training in:

- (a) Security awareness;
 - (b) Inmate supervision and surveillance;
 - (c) Suicide prevention;
 - (d) Training in unarmed self-defense, first aid, and CPR;
- (3) Those persons set out in paragraph (H) of rule 109:2-11-01 of the Administrative Code shall complete the training prescribed in paragraph (D) of rule 5120:1-10-18 of the Administrative Code as follows and any other training prescribed by the executive director. During the first year of assignment shall include at least eight hours of training in:
- (a) Jail security, including admission and release;
 - (b) Inmate jail searches;
 - (c) Inmate supervision, surveillance, and discipline;
 - (d) Emergency responses and procedures;
 - (e) Recognition of abnormal inmate behavior including suicidal behavior; mental/emotional disorders and retardation; and substance abuse;
 - (f) Overview of the "minimum standards for jails in Ohio."
- (B) It shall be clearly understood that the jailer training program described in these rules is designed as a minimum program. The jailer training program administrator is encouraged to exceed the minimum program wherever possible and appropriate.
- (C) Instruction in such matters as departmental rules and regulations, local ordinances, personnel policies and procedures may be given entirely upon local initiative. No portion of the instructional time devoted to this training shall be credited against the hours of instruction required by rule 5120:1-10-18 of the Administrative Code or by the executive director.
- (D) The executive director may require certain topics and a minimum number of hours of entry level jailer training in addition to the topics and training hours prescribed in rule 5120:1-10-18 of the Administrative Code. The executive director shall require

specific student performance objectives be instructed during entry level training and may provide lesson plans. A list of student performance objectives may be requested from the executive director.

- (E) The executive director may require certain topics be instructed during in-service training which shall not conflict with the topics or training hours prescribed in rule 5120:1-10-18 of the Administrative Code and may provide lesson plans.
- (F) After October 1, 1993, no person convicted of a felony shall be permitted to attend any portion of a training program approved by the executive director.
