This rule is being rescinded as part of the update Chapter 120 of the Ohio Administrative Code. This rule will be replaced with a new rule due to changes in text that exceeded 50% of the current rule as it exists. The purpose of the update is clarify the rules approved by the Ohio Public Defender Commission in language that is more clear, accessible and hopefully lends itself to less confusion. The rules have not been updated since 2000, and both the Ohio Public Defender and the Ohio Public Defender Commission felt that revisions and updates were necessary both to

bring our agency into compliance with the review process and to give better guidance to those who provide for representation of indigent defendants.

The rule establishes the training and qualification for a defense attorney to handle different levels of criminal cases from misdemeanor to death penalty cases.
