Authorizes the Director of Transportation to assign an employee of the Department of Transportation to duties other than those assigned to the position to which the employee has been appointed, and sets forth the limitations and parameters

surrounding such an assignment. Requires the Director of Transportation to assign employees on the basis of seniority if the number of eligible employees who consent to the assignment exceeds the number of employees needed. Sets forth that no employee who is temporarily assigned work duties should suffer any loss of pay, position, diminution of position, service rights or benefits as a result of the temporary position. Outlines that an employee should not be temporarily assigned duties if such duties are those of an a higher classification at a higher pay range. Sets forth that performance evaluations should not include the employee's performance of the temporarily assigned duties.
