Sets forth the guidelines to be used when conducting a civil service examination. Deletes an outdated notice requirement for examinations. Modifies the method for notifying an applicant of an examination or interview. Eliminates the ability of the examination taker to review their own exam papers and the associated objection process. Adds the Director's designee as an addition in places where the Director is referenced. Eliminates the Director's ability to waive the requirements of the rule under certain circumstances. Eliminates release time for employees to take a civil service examination.
