the Division's prior approval and prescribes how an agency agreement is made. The rule provides that prior approval must be sought if a state savings bank wants to contract to provide services to its customers through a non-affiliate depository institution or to provide other services than the rule allows. The rule clarifies that a state savings bank may not as agent or principal through its agent conduct activities prohibited under applicable law and that the bank office or branch of the depository institution acting as the savings bank's agent is not a branch of the savings bank.
