The Division will receive applications from education providers for the approval of continuing home inspection education classes. These applications will need to be reviewed by Division staff. Education providers will be assessed a fee pursuant to proposed Ohio Administrative Code 1301:17-1-03. Any increase in revenue received by the Division from this proposed rule will be significantly off-set by the increased costs for additional staff needed for the implementation of Chapter 4764. As this is a new licensing program, estimates of education applications received will be quite speculative. The Division estimates it will receive 50 to multiple hundreds of applications each year.

12. What are the estimated costs of compliance for all persons and/or organizations directly affected by the rule?

An education provider will have to pay the fees as required in proposed rule 1301:17-1-03 and as authorized by Ohio Revised Code Section 4764.05. They will also have to spend time completing the application, which the Division estimates will take 30 minutes to complete.
