The Division does not anticipate an increase or decrease in its revenue or expenditures in the current biennium due to this rule.

13. **What are the estimated costs of compliance for all persons and/or organizations directly affected by the rule?**

Relevant to the amendment being proposed in this rule package, the cost of compliance for persons directly affected by the rule includes applicants for each of the three types of pressure equipment for which licensure is being sought. Under current law, applicants to obtain a low-pressure boiler operator license they must obtain "[s]ix hundred hours of operating experience associated in the direct care, custody, and control" of the equipment for which licensure is being sought. The proposed amendment reduces this amount to four hundred hours.

Applicants to obtain a license to operate high pressure boilers as well as stationary steam engines currently must obtain one thousand hours of experience under current

law. The proposed amendments seek to reduce this amount to seven hundred hours. Additionally, if the applicant has obtained a license under this rule and is seeking to obtain licensure for additional equipment (a low-pressure boiler operator seeking to obtain a license to operate high-pressure boilers for example), under current law five hundred additional hours of experience must be obtained. The proposed amendment seeks to reduce this amount to four hundred hours.

Not specifically. This rule only establishes the educational, training, and experience requirements that must be demonstrated to obtain a license. The requirement for the license is imposed by sections 4104.05 and 4104.19 of the Revised Code.
