The branch office definition and Form BR are nationwide initiatives spearheaded by the North American Securities Administrators Association ("NASAA"), the NASD, and the U.S. Securities and Exchange Commission ("SEC"), to create uniformity as to what constitutes a branch office and to create a uniform mechanism for filing. The addition of the term "promptly" will require licensees to amend or update filings within 30 calendar days of knowing of facts and circumstances giving rise to an amendment or update. The addition of this term mirrors the NASD requirements imposed upon

dealers and their registered representatives.
