Additionally, the rule is being amended to permit the Division to terminate license applications that have been pending with deficiencies for over a year. Also, the rule requires investment advisers to notify the Division of branch offices by incorporating the new, uniform Form BR within our required regulatory filings.

This proposed amendment would provide notice to the Division of branch offices located within Ohio of any Ohio licensed investment advisers. The branch office definition and Form BR are initiatives spearheaded by the NASD, SEC, and NASAA to create nationwide uniformity as to what constitutes a branch office and to create a uniform mechanism for filing.
