For those members of the public that wish to be notified in advance of all meetings related to a certain type of public business, they can write the Chief and request to be notified of any meeting that discusses the type of business they've indicated in their letter. The Chief will then send a letter to this person a notice of the date, time, location, and type of business that will be discussed at the meeting at least four calendar days in advance of the meeting date, unless it is an emergency meeting.

The Chief will also maintain a list of any media sources who have requested, in writing, to be notified of any special or emergency meetings. The media must supply the name, mailing address, and phone number of the represented to be contacted of such notices. For special meetings, the Chief will then notify these representatives via mail at least four days prior to the meeting date or call twenty-four hours in advance of the meeting date. For emergency meetings, the Chief will notify these media sources immediately of the date, time, location, and topic of the meeting.
