It is proposed to amend this rule to add crappie regulations at Pymatuning Lake which would provide for a daily bag limit of twenty crappie, and a size limit of nine inches. It is felt that this change will result in an improved fishery for this highly sought-after species. It will also provide consistency with Pennsylvania regulations for Pymatuning Lake.
