It is recommended that this rule be also amended to allow persons to take fish on Pymatuning Lake with up to three lines. This rule change will be consistent with the state of Pennsylvania.

Pymatuning Lake is located in northeastern Ohio (southeastern Ashtabula County) and also crosses over into the state of Pennsylvania. It is the largest inland lake in Ohio at 16,349 acres. The fisheries resources of Pymatuning Lake are managed jointly by the Ohio Division of Wildlife and the Pennsylvania Fish and Boat Commission. Boat anglers may have a license from either Ohio or Pennsylvania to legally fish the waters.
