This rule designates those species of wildlife in Ohio that are endangered. The amendments to this rule will make the appropriate changes to the current list of endangered wild animals found in Ohio. Additions and deletions are based on the biological data for each of the species' current and projected populations.

It is proposed to amend this rule by removing the northern madtom (Scioto madtom) from the endangered species list. The U.S. Fish and Wildlife Service has determined this species is extinct based on rigorous reviews of the best available science.

It is proposed to amend this rule by transferring the language for bobcat hides legally acquired from outside Ohio to OAC 1501:31-15-02 since bobcats are not endangered
