This rule establishes the dates annual hunting licenses, deer, turkey and fur taker permits, and wetland habitat stamps are valid and provides that licenses and permits may be issued in either printed or electronic form.

This rule will be rescinded and replaced due to the number of changes. The additional changes from the prior version of this rule include the following:

• It is proposed to amend this rule to remove the reference to the nonresident Lake Erie sport fishing district permit. The Ohio Revised Code section that established this permit has been rescinded.

• It is proposed to amend this rule to allow the chief to establish combination license packages in accordance with section 1533.321 of the Ohio Revised Code. Any established combination license package will be discounted five percent from the price of licenses if they were purchased separately. The price will be rounded up to the nearest whole cent to ensure the total discount does not exceed five percent as specified in the Revised Code.

• It is proposed to make grammatical changes that are not substantive. It is further proposed to rename this rule as "1501:31-27-02 | Annual licenses and permits; combination license packages."
