Because ODA changed its mission statement in 2007 to more accurately reflect the scope of the mission given to ODA by the General Assembly, ODA is now submitting this proposed amended rule for a review under Chapter 119 of the Revised Code so that amended rule might incorporate ODA's new mission statement.

This proposed amended rule introduces ODA. As part of that introduction, the change being proposed by this rule is to change the mission of ODA from a department that administers "various state and federal programs benefitting Ohioans sixty years of age and older" to a department that administers "various state and federal programs to provide leadership for the delivery of service and supports that improve and promote quality of life and personal choice for Ohioans sixty year of age or older, adults with disabilities, their families, and their caregivers." This change is being proposed so that paragraph (A) accurately reflects the mission given to ODA by the Ohio General Assembly, since the General Assembly has given ODA the authority to administer the Best Rx program under sections 173.71 to 173.91 of the Revised Code, the Golden Buckeye Card program under sections 173.06 and 176.061 of the Revised Code, the Residential State Supplement program under sections 173.35 and 173.351 of the Revised Code, the Long-Term Care Consultation program under sections 173.42 and 173.43 of the Revised Code, and the Alzheimer's respite program under section 173.04 of the Revised Code. Such programs help Ohioans under sixty years of age as well as those sixty years of age and over.

This proposed amended rule also defines six terms used throughout the various rules adopted by ODA.

On October 17, 2007, ODA revised this proposed amended rule to provide an improved public hearing notice, to improve the RSFA, and to improve the grammar in the rule language without changing it in any substantial way.

On November 16, 2007, ODA revised this proposed amended rule to do the following:

- 1. Modify the definitions of the terms "area agency on aging" and "planning and service area." The goal is to eventually define all identical terms used in rules at ODA with identical definitions. These modifications are part of that process.
- 2. Consistently use AAA, ODA, and PSA throughout this rule.
- 3. Update this RSFA.

On November 28, 2007, ODA refiled this proposed amended rule to make the following changes:

- 1. The first sentence in paragraph (A) was changed. It formerly read as follows: "The Ohio department of Aging (ODA) was created by the general assembly to administer various state and federal programs to provide leadership for the delivery of services and supports that improve and promote quality of life and personal choice for older Ohioans, adults with disabilities, their families, and their caregivers." It was revised to read as follows: "The Ohio department of Aging (ODA) was created by the general assembly to administer various state and federal programs to provide leadership for the delivery of services and supports that improve and promote quality of life and personal choice for Ohioans sixty years of age and older, adults with disabilities, their families, and their caregivers."
- 2. Because paragraph (B)(5) defines "Older Americans Act," in paragraph (B)(1) the full citation of the Older Americans Act was shortened to simply "Section 306 of the 'Older Americans Act.""
- 3. This RSFA was improved.
