This proposed new rule will exist to establish administrative standards for the ombudsman registry and the hiring process for ombudsman program specialists or program directors.

This proposed new rule will establish administrative standards for the ombudsman registry and the hiring process for ombudsman program specialists or program directors.

Because ODA's proposed amendments to the current version of this rule would amend approximately 50% of that rule, ODA proposes to adopt this new rule to replace the current rule in compliance with §4.3.1 of the Legislative Service Commission's Rule Drafting Manual. ODA's proposed new rule will achieve the following in comparison to the rule that it will replace:

1. Reduce the unnecessary use of the regulatory-restriction word "shall" in this rule to comply with R.C. §121.951.

2. Present administrative standards for the ombudsman registry before administrative standards for the hiring process for ombudsman program specialists or program directors.

3. Make additional non-substantive improvements to this rule, including replacing the passive voice with the active voice to comply with §5.8.6 of the Rule Drafting Manual.

2. "SLTCO...SHALL NOT approve an applicant" with "the SLTCO reviews the applicant's qualifications." Instead, ODA will use "the SLTCO shall review the applicant's qualifications."
